

"[E]nhance the creative and innovative potential of researchers holding a PhD, wishing to acquire new skills through advanced training, international, interdisciplinary and inter-sectoral mobility."

- · Monobeneficiary: One researcher, one host organization
- Two types: European and Global Fellowships
- Host organization must be in EU or Horizon Europe Associated Country
- Open to all research domains, including Euratom
- Open to "excellent researchers of **any nationality**" (restrictions for GF and Euratom)

Who participates?

1 institution (with suitable research capacity)

- established in any EU or Horizon Europe associated country
- in cooperation with a Partner Organisation established in a third country (Global Fellowships)

1 researcher

- any nationality (check details for GF!)
- PhD unconditionally defended on 13.09.23
- max. 8 years (FTE) of research work after PhD



Example 1

European Fellowship

 Polish researcher awarded a PhD in 2019 in the UK, remains resident there. Applies for a European Fellowship in the field of nanotechnology together with a host institution in Poland.

• **<u>Eligible?</u>** Awarded a PhD before the Call deadline; less than 8 years since award of PhD; has not resided in Poland for more than 12 months in previous 3 years.

Example 2

Global Fellowship

• Researcher of Polish origin, PhD defended in July 2015, has worked on a reseachlecturer post since then. Left Poland in July 2022 and is now working in Canada. He apllies for the MSCA-PF for a research work to be continued in Canada, in collaboration with his alma mater in Poland.

• Is he eligible?

- Please pay attention to which institution should be the applicant (and beneficiary-to-be) the one established in Poland $\sqrt{}$
- The actual number of FTEs of research work would need to be determined ?
- Researcher has been active in Canada for more than 12 months (before 13.09.23) ≠





Key points about MSCA-PF

Postdoctoral researchers only [ELIGIBILITY]

Max. 8 years FTE postdoctoral research experience [ELIGIBILITY]

Researcher mobility scheme [ELIGIBILITY]

Training and career development through research

Non-Academic Placements possible (up to 6m at end of project)

Secondments encouraged (worldwide, up to 1/3 of project duration)

12-24m (EF) or 24-36m (GF) + Non-Academic Placement (max. 6m)



EU contribution


- Unit contribution
- Grant budget based on number of person-months proposed
- Financial reporting based on number of person-months worked
- Full employment contract
- NEW! Changes to the personal situation (allowance entitlement) of the researcher can be taken into acount during the project implementation





Gender equality in Horizon Europe (3 main levels)

- <u>Gender Equality Plan</u> obligatory for public bodies of EU MS and HE AC
- gender dimension in research and innovation required and evaluated
- gender balance among research teams, project boards, etc.





MSCA Postdoctoral Fellowships 2023 Project proposal

PARTA (Application Form)

- web-based form,
- project acronym and title
- > scientific area, 3-5 pre-defined descriptors
- free keywords
- abstract: max. 2000 characters
- previous submissions?

> Researcher:

- Doctorate: date of (expected) award
- Qualifications
- Place of activity/place of residence (previous 5 years most recent one first)

> Participating organisations:

- Host institution (beneficiary-to-be): Participant Information Code (PIC) declarations, ethics issues, supervisor
- Global Fellowship: partner organisation
- Non-academic Placement (if opted for)



MSCA Postdoctoral Fellowships 2023 Project proposal

PART B (Technical description)

Part B1 (10 pages!)

- > main text
- structure according to headings
- do not delete the tags
- important: font type and size (text and tables) yes, it is checked!

Part B2 (no page limit)

- Researcher CV
- Capacity of participating organisations
- Ethics, security if pertinent
- Global Fellowship letter of committment by partner organisation (TC)





MSCA Postdoctoral Fellowships 2023 Proposal evaluation

Evaluation criteria:

Excellence (50%)

- Research and innovation objectives (ambitious? go beyond the state of the art?)
- Soundness of methodology (interdisciplinary? gender dimension? other diversity aspects? open science?)
- Supervision, training, 2-way transfer of knowledge (researcher vs. organisations)
- Quality and appropriateness of researcher's professional experience, competences and skills

Impact (30%)

- Researcher: measures to enhance the career perspectives and employability
- Measures to maximise: dissemination and exploitation plan, communication activities (outreach)
- Citizens: project's contribution to the expected scientific, societal and economic impacts

Quality and efficiency of implementation (20%)

- Effectiveness of work plan (risks, effort vs. task vs. time think: project management)
- Capacity of host institutions, including hosting arrangements •



MSCA Postdoctoral Fellowships 2023 Proposal evaluation

> Only one proposal per individual researcher can be submitted.

- Proposals scoring equal to or above 70% will be considered for funding within the limits of the available call budget. Other proposals will be rejected.
- Proposals having received a score of less than 70% must not be resubmitted the following year (same researcher, same organisation(s))
- ERA Fellowships (<u>"widening</u>" countries)
- Seals of Excellence will be awarded to applications with a total score equal to or higher than 85%, but which cannot be funded due to lack of budget available to the call > Ulam NAWA

- Monitoring of actions, grant agreements, public procurement contracts


In addition, experts provide opinion and advise on:
