







## Information clause of the Polish National Agency for Academic Exchange regarding the processing of personal data of participants and speakers of the 1st Congress of Internationalisation (an event organised within the scope of a project financed by the European Funds for Social Development 2021-2027)

Legal basis for data processing	The Agency processes your personal data on the basis of Article 6(1)(c) and (e) of the GDPR <sup>1</sup> , and on the basis of Article 9(2)(g) and (j) of the GDPR in conjunction with Article 6(1)(c) and (e) of the RODO in order to:
	1) perform the public task carried out in the public interest in the field of internationalisation of higher
	education and science vested to the Agency, as defined in Article 2 of the Act of 7 July 2017 on the National Agency for Academic Exchange
	2) fulfil the Agency's legal obligations in connection with the implementation of the project funding agreement,
	including obligations concerning statistics and those related to monitoring, reporting, communication, publication, evaluation, financial management, verification and performance of project audits, and to determine the eligibility of participants.
	If you consent to the processing of your image, the Agency processes it pursuant Article 6(1)(a) of the GDPR.
Types of personal data and	The Agency may process the following categories of your data:
categories of data subjects	1) identification data: first name, surname, e-mail address, contact telephone number, mailing address and name of the represented institution, internet identifiers - for the registration of the participant and speaker of
	the Congress; 2) data concerning the participant's and speaker's PESEL (the Polish ID) number or date of birth - for the purposes of group accident insurance coverage;
	3) data concerning possible special organisational needs resulting from a disability, which constitutes data on
	health status referred to in Article 9 of GDPR - only for persons participating in the Congress on the premises of the Medical University of Gdańsk;
	4) data concerning the image of persons participating in the Congress - on the basis of a separate and voluntarily given consent;
	5) data concerning education, professional experience - in order to prepare biographical notes of the Congress
	speakers;
	6) data necessary for the reimbursement of travel expenses for Congress speakers.
Period of data storage	Your data will be processed by the Agency until the purpose of the processing ceases to exist, or for the period resulting from the archival category of documents in which the data are included, as specified in the executive regulations of the act of 14 July 1983 on national archival resources and archives.
	You may revoke your consent for the processing of your image at any time.
Data recipients/data processors	With all guarantees for the security of your data, the Agency may make it available to other entities on the basis of pertinent legal regulations, in particular to other data controllers in accordance with the Implementation Act <sup>2</sup> (i.e. to the Minister responsible for regional development – the Managing Authority of the European Funds for Social Development 2021-2027 Programme and to the National Centre for Research and Development – the Intermediate Body), or provide it to processors on the basis of the pertinent data
	processing agreement, in particular to the entity commissioned to organise the Congress.
Transfer of your data to third	Your data will not be transferred to any third country or an international organisation. Should it be necessary
countries	to transfer your data to a third country, the Agency will provide adequate safeguards for the transfer and
	effective legal remedies, in particular the standard contractual clauses adopted by the European Commission, and will inform you accordingly.
Automated decision making including profiling	The processing of your data is not carried out by automated means. Your data is not subject of profiling at the Agency.
Requirement to provide	The Agency obtains the data directly from the data subjects or from the institutions and bodies registering
data/data source	their representatives for the event. A refusal to provide data means that a particular person will not be able to
	participate in the event.
Your GDPR rights	Pursuant to the GDPR you have the right to request access to your personal data, rectification of your data,
	data portability and restriction of the processing of your data by the Agency.
	In case of violation of the provisions on the personal data protection, the you can lodge a complaint with the President of the Personal Data Protection Office.
