CALL FOR PROPOSALS FOR PARTICIPATION IN THE PROGRAMME POLONIST NAWA No 7/2025 of 3 February 2025

I. SCOPE OF RECRUITMENT

Pursuant to Article 19(1) of the Act on the National Academic Exchange Agency of 7 July 2017. (i.e. Dz. U. of 2023, item 843, the Director of the National Agency for Academic Exchange announces a call for applications for participation in the Scholarship Programme for Students and Researchers - NAWA Polonist - Call for Researchers (hereinafter the "Programme").

II. PROGRAMME DESCRIPTION

2.1. Objective of the Programme

The aim of the Programme is to popularise the Polish language, to popularise Polish studies and research in the world and to strengthen and support the development of foreign and Polish academic centres that carry out such studies and research. The Programme supports the mobility of academic staff - researchers and academic teachers, specialists in Polish language, Polish culture, literature, history and art.

2.2. Eligible applicants Inbound

Eligible to apply for a scholarship from the National Academic Exchange Agency are Applicants who meet all of the following criteria:

- 1) are scholars whose subject is the Polish language, Polish literature,
- art, culture or history;

2) hold a minimum of a doctoral degree or an equivalent degree obtained abroad at the time of application;

3) are employed w in a foreign university or w a foreign scientific/research centre;

4) have a certificate/request from the Host Centre, which is an institution of the Polish system of science and higher education belonging to one of the following categories:

a) universities referred to in Article 7(1)(1) of the Act of 20 July 2018. Law on Higher Education and Science;

b) scientific institutes of the Polish Academy of Sciences, acting on the basis of the Act of 30 April 2010 on the Polish Academy of Sciences;

c) research institutes, operating on the basis of the Act of 30 April 2010.

- d) Polish Academy of Arts and Sciences,
- 5) can demonstrate at least one achievement among those indicated below:

a) authorship or co-authorship of a scientific article published within the last 5 years (calculated from the beginning of 2020 in a reputable international scientific journal),

authorship or co-authorship of a scientific article published within the last
 years (calculated from the beginning of 2020) in peer-reviewed international conference proceedings,

c) authorship or co-authorship of a scientific monograph or a chapter in a scientific monograph published within the last 10 years (counted from the beginning of 2015),

6) are foreigners (do not have Polish citizenship and have not submitted an application for Polish citizenship) or have Polish citizenship, but conduct their research and teaching activities outside Poland and have been employed in a foreign university or research centre for at least 3 years from the closing date of the call,

7) have not been awarded a scholarship within two years of the closing date of the call for proposals

Applicants who meet the following criteria together are eligible to apply for a National Academic Exchange Agency scholarship:

1) are researchers or academic teachers whose research or teaching focus is the Polish language, Polish literature, art, culture or history;

2) hold a minimum of a doctoral degree or an equivalent degree obtained abroad at the time of application;

3) their primary place of employment (at the time of application) is an institution of Polish or foreign higher education and science that conducts research or teaching activities in the field of teaching Polish language, Polish culture, art, literature, history;

4) have an invitation from the host institution, which may be a foreign university that offers a degree in Polish studies or Polish philology;

5) can demonstrate at least one achievement among those indicated below:

a) authorship or co-authorship of a scientific article published within the last 5 years (calculated from the beginning of 2020 in a reputable an international scientific journal),

b) authorship or co-authorship of a scientific article published within the last 5 years (counting from the beginning of 2020) in peer-reviewed International conference proceedings,

c) authorship or co-authorship of a scientific monograph or chapter in a scientific monograph published within the last 10 years (counted from early 2015),

6) have Polish citizenship;

7) have not been recipients of the NAWA Polonist Programme within two years of the closing date of the call.

Maximum number of applications an Applicant may submit	The National Agency for Academic Exchange stresses that the Applicant is obliged to read the call documents, in particular the programme's merit evaluation criteria, before preparing the application and the required annexes. It is up to the applicant to present the project (scientific output, host site and description of planned research) in such a way as to enable both the team evaluator as well as the reviewers an adequate assessment of the proposal.

2.3. Deadline and other conditions for submitting an application

2.4. Thematic scope of the Programme activities

<u>1.</u> Inbound offer

The programme enables researchers from foreign academic and scientific centres to carry out mobility lasting from 3 to 12 months, as part of which they may conduct research or research and didactic projects in Polish universities and scientific institutions. The following activities, among others, are possible as part of the mobility: conducting scientific research (including in cooperation with the Polish scientists), acquiring

research materials, preparation of scientific publications, post-doctoral training, teaching at the host centre, intensive learning of the Polish language.

The Polonist Programme Scholarship is open to applicants who, as part of their mobility, will carry out research projects on topics related to the Polish language, Polish language glottodidactics, literary studies, comparative studies, Polish culture, art or Polish history.

Applicants in the course of recruitment must provide a certificate from the Host Centre confirming their willingness to host a NAWA scholarship holder.

2. Travel offer

The programme also enables Polish scholars and academic teachers to undertake mobility, which may include research, teaching or collaborative projects to prepare grant applications in foreign academic centres that offer Polish studies, Polish studies or Slavonic studies with Polish at least at Bachelor's level. Applicants may apply for a scholarship for projects lasting between 3 and 12 months.

The Programme is open to projects aimed at strengthening and expanding the activities of academic centres offering Polish studies, Polish studies and Slavonic studies in Polish.

2.5. Project implementation timeframe

2.6. List of information required in the application and annexes to the

1) a scientific curriculum vitae of no more than 3 pages (size

pages - A4, font size at least 11 pt), covering, inter alia:

a) education, course of studies/career academic and scientific background,

including the Applicant's subsequent places of employment;

b) information on internships, awards, membership of societies and scientific organisations and other important achievements;

c) information on completed and ongoing research projects, highlighting international projects.

2) A scan of the doctoral diploma or confirmation of the award of the doctoral degree, together with an officially certified translation into English if the original language is a language other than Polish, English or Latin;

3) a scan of the confirmation of employment issued not more than 3 months before the date of the call for applications under the Programme;

4) a publication list of up to 10 major papers published or accepted for publication in the last 10 years (calculated from the beginning of 2015);

5) scans of two scientific publications of the Applicant's choice; in the case of a monograph, a file containing information its review, title page, editorial page, table of contents and a selection of excerpts containing the author's key theses should be attached; publications in a language other than Polish or English should be accompanied by a translation;

6) a scan of the invitation (Attachment 5.) from the Host Centre confirming their willingness to host the NAWA scholarship holder for the requested period. The invitation should be issued no earlier than 3 months prior to the announcement of the call and signed by the academic supervisor and another person holding a managerial position at the Host Centre (e.g. dean, rector) in accordance with the rules in force at the given Centre (the document should be signed by two persons). The document should contain the following information: details of the Applicant, contact details of the Host Centre, details of the organisational unit where the project is planned, details of the supervisor, length of stay, indicative activity plan and scope of support from the Host Centre;

7) a scan of a proof of citizenship document, e.g. passport.

Annexes in a language other than Polish or English must be translated into Polish or English (a translation certified by a sworn translator - or a translation certified by a Polish diplomatic mission or host centre - is acceptable).

When attaching a scan of a document, the photograph must be obscured and attaching a document with a photograph implies consent to the processing of personal data in this respect.

The above lump sum represents the total amount for the trip.

4. Monthly support of PLN 2,000 provided for a scholarship holder who, as at the date of submission of the application, has a minor child or children as dependants. The allowance is available to the scholarship holder for the duration of the children's stay with the scholarship holder in the country of the scholarship implementation. The birth of a child after the application has been submitted does not entitle the scholarship holder to apply for an increase in funding.

5. If the scholarship holder has a severe or moderate disability certificate, the lump sum for living and accommodation costs may be increased by PLN 2,000 per month at the scholarship holder's request.

6. The full monthly rate of the stipend, living and accommodation lump sum and support per child/children applies if the Applicant's stay (or children respectively) according to the final report is 15 days or more. For less than 15 days, half the rate applies.

Example calculation of the amount of funding due calculated as part of the verification of the final report:

1) if the Applicant has planned 7 months of stay in the application and the actual stay lasted 6 months and 14 days, he will receive the amount for 6.5 months,

2) if the Applicant has planned 7 months of stay in the application and the actual stay lasted 6 months and 17 days, he will receive the amount for 7 full months of stay,
3) if the Applicant planned 7 months of stay in the application and the actual stay was 7 months and 2 days, the Applicant will receive the amount for 7 full months of stay - i.e. the maximum amount indicated in the application.

7. Insurance and visa costs, if required, are borne by the Scholarship Holder.

8. The funds under the Programme are understood as the funds referred to in Art. 18 para. 2 item. 1 u.n.a.w.a. Pursuant to Art. 21 (1) (39a) of the Personal Income Tax Act of 26 July 1991, the aforementioned funds are free of income tax.

9. The programme does not provide funding funding for institutions (costs of

indirect) or research costs (e.g. costs of materials, participation in conferences, publications). Research and other expenses must be covered by other sources.

2.9. Payment schemes

Payments will be transferred to the grantee's bank account held in a bank operating in the territory of the Republic of Poland and will be implemented as follows:

a) an advance payment - amounting to 90% of the total funding, transferred to the grantee's bank account upon its indication, within 30 days from the date of transmission of the correct confirmation of the commencement of the Project;

b) a balancing payment of up to 10% of the total funding, to be made within 30 days of the date of approval of the final report by the Agency.

2.10. Documentation of expenditure

The funding awarded, being a statement of lump sums, will be treated as expenditure incurred. Within the framework of the lump sums, the Grantee is not obliged to collect and submit accounting evidence to support the expenditure.

In order to confirm that the mobility has been carried out, the grantee is required to keep the documents confirming travel to and from the Host Centre and attach scans of these documents to the final report. The grantee is required to keep documents confirming travel to and from the Host Centre for accompanying children and make them available on request.

In addition, upon NAWA's request, the Grantee shall be obliged to present documentation confirming the implementation of the activities and the achievement of the anticipated results and outputs in accordance with the approved Application - under pain of the Grantee ineligible.

2.11. Submission and verification of reports

1. The grantee is required to submit a report on the implementation of the Project through the Agency's ICT System and to provide confirmation of the start of the activities at the Host Centre:

1) Confirmation of the start of mobility by the Grantee, issued within 14 days of the start of the Project, signed by the Host Centre Representative.

2) The final report shall be submitted to the Agency's ICT System within 30 days of the end of the mobility in accordance with the model report.

2. A duly drawn up report is subject to verification by the Agency and acceptance for the compliance of the Project execution with the Agreement.

The Agency may decide to subject the report to an evaluation by a Panel of Experts. The information contained in the report is used to assess the reliability and correctness of the implementation of the activities planned in the Project and the disbursed funds, as well as the relevance of possible changes carried out during the implementation of the mobility.

3. In the final report, the Grantee shall take into account any deviations during the mobility that affect the amount of funding awarded, in particular those related to the shortening of the mobility.

4. Funds not used or used incorrectly shall be deducted from the balancing payment or shall be repaid to the Agency's bank account within 14 days of the date of the request for repayment if they exceed the amount of the balancing payment.

2.12. Rights and obligations of the programme grantee

The scholarship recipient is obliged

the communicate to the Host Centre the decision of the NAWA Director to award the scholarship within 30 days of its receipt in the NAWA System;

2) provide NAWA with confirmation of commencement of tasks under the scholarship awarded at the Host Centre within 14 days from the date of commencement of the project (confirmation must be signed by the Scholarship Holder's supervisor);

3) have at least basic health insurance covering the period of travel and stay in the Host Centre, including in particular insurance for medical expenses and transport to hospital. Scholarship recipient

who is a national of one of the Member States of the European Union, insofar as he is subject to

there insurance, he shall be in possession of at least the European Card Health insurance;

4) the timely submission of the Final Report to the ICT System Agency;

5) the realisation of the Project results planned in the application;

6) to inform NAWA without delay of changes in the implementation of the scholarship;

7) inform NAWA of their academic or teaching successes - both during the payment of the scholarship and at the reporting and evaluation stage;

8) the proper implementation of the scholarship agreement, in particular to account for the funds awarded;

9) implementation of mobility; the grantee authorises the Agency to disseminate information about his/her activities, including the results achieved, for example by recording podcasts, giving interviews, etc.

The grantee may be additionally employed by the Host Centre if required by its regulations. The grantee is obliged to inform the Agency immediately of any problem or irregularity that threatens or may threaten the proper implementation of the project, including a possible dispute with the host Centre.

2.13. Amount of funds available in the call

The total allocation for the call is PLN 1 400 000, although the Agency reserves the right to change the allocation of funds.
